## REGULATION OF THE BATHING ESTABLISHMENT

## **GENERAL RULES**

- 1. THE BATHING ESTABLISHMENT IS OPEN FROM 8.00 AM TO 8.00 PM OF EVERY DAY.
- 2. THE FRUITION OF SERVICES OFFERED CAN 'DURING THE OPENING TIME OF THE BATHING AND IT IS CONDITIONED TO THE ADVANCE PAYMENT OF THE SUMS CORRESPONDING TO THE REQUIRED PERFORMANCE, ACCORDING TO THE RATES PROVIDED BY THE PRICE LIST EXPOSED TO THE ENTRY.
- **3.** THE ACTIVITY OF THE BATHING ESTABLISHMENT BEGINS WITHIN 15 JUNE AND END OF THE 15TH SEPTEMBER OF EVERY YEAR, WILL BE CARE OF THE DIRECTION OF THE BATHING STABILITY COMMUNICATE EVERY YEAR THE ACTIVITY OF ACTIVITY COMPATIBLE TO THE NEEDS OF THE ESTABLISHMENT.
- **4.** THE CUSTOMER IN THE POSSESSION OF THE SUBSCRIPTION CARD HAS THE OBLIGATION TO EXIBUTE EVERY SOME ENTRY IN THE BALNEAR FACILITY AND AT ANY TIME ON REQUEST OF THE PERSONNEL FOR CONTROL OF THE BALNEAR FACILITY.
- **5.** THE PERSONAL CARD IS NOT LIABILITY TO THE OWNER AND WHICH IS USED BY ANOTHER PERSON LOSS ITS VALIDITY, RESERVING THE DIRECTION THE FACULTY TO PROCEED WITH THE RESPONSIBLE UNDER THE LAW.
- **6.** THE PRIVATE SUBSCRIPTION OF THE CARD IS PAYED TO PAY ANYWHERE THE ENTRANCE TO THE SERVICES OF THE BATHING ESTABLISHMENT WITHOUT LAW TO ANY FOLLOWING REIMBURSEMENT.
- 7. THE HOT AND COLD SHOWERS WITH SOAP USE ARE PAYABLE BY BUYING TOKENS.
- 8. COLD SHOWERS WITH PROHIBITION OF SOAP USE BEFORE SEA FRONT ARE FREE.

## **INTERNAL RULES**

- 1. THE BATHING ESTABLISHMENT DOES NOT RESPOND TO ANY PARTIAL AND / OR TOTAL FACTS, IN THE CABINS, UNDER THE UMBRELLA SEAT, IN THE PARKING AND IN THE END OF THE BATHING ESTABLISHMENT.
- 2. IT IS FORBIDDEN TO THROW CIGARETS OF CIGARETTE OR CARDS ON ARENILE AND ADJACENT ZONES.
- 3. IT IS FORBIDDEN TO MOVE THE EQUIPMENT SUPPLIED BY AN UMBRELLA TO ANOTHER.
- 4. IT IS FORBIDDEN TO LEAVE GAMES OR MORE THAN TO THE UMBRELLA BEYOND THE OPENING TIME OF THE FACTORY.
- 5. IT IS ABSOLUTELY FORBIDDEN TO PRACTICE ANY GAME, ON ARCHAIL, PLATFORMS AND IN THE FIELD OF THE WATER MIRRORS INTENDED FOR BATHING, WHICH ARRECTS MOLESTIA, DAMAGE AND TURBULATE TO THE PUBLIC QUIET.
- 6. IT IS ABSOLUTELY FORBIDDEN TO OPEN THE BEACH UMBRELLA OR UMBRELLAS IF THE DIRECTOR MAKES THE CONDITIONS AS WELL AS THE STRONG WIND ..
- 7. ALL THE BEHAVIORS THAT ARRECHINO DAMAGE TO THE DECORATION AND HYGIENE OF THE BALNEAR STRUCTURE ARE NOT FORBIDDEN (to leave messy clothes to the parasol, to lay with dishes on the beach and similar behaviors)

THE CUSTOMER MUST OBSERVE THE PROVISIONS OF THIS REGULATION AND OF THE ORDINANCES OF THE PORTFOLIO OF PORTO DI LIVORNO AND THE MUNICIPALITY OF ROSIGNANO MARITTIMO, EXPOSED TO THE ENTRANCE OF THE BALNEAR FACILY. THE ADOPTION OF THE CUSTOMER OR ADVENTOR OF BEHAVIOR THAT CAN CREATE DISORDER CAUSING DAMAGE WILL CAUSE IMMEDIATE REMOVAL FROM ESTABLISHMENT WITH RESERVE OF DENOUNCATION TO THE PUBLIC SECURITY AUTHORITIVES AND REQUESTING ANY IMMEDIATE DAMAGE.
